- 7.Q Approval of expanding existing Custom Data Processing (CDP) system which was approved by Council on Feb 16, 2022. CDP is currently being used by DCHD's Environmental Health Division and CDP's ezEMRX solution to be added for expanded use for the Delaware County Health Department's need for clinical support as an Electronic Health Record (EHR). The expanded contract will have an expected total contract cost from January 1, 2023 through August 31, 2025 of approximately \$199,445.04 which includes total anticipated implementation fees. Grant

There is ample funding in the Enhancing Detection Expansion funds that are available in what we are internally calling the ELC Cares Grant. There is currently \$596,715.00 available for Hardware and Software for laboratory and elec. surveillance, and we have taken the added step of clarifying with the State that we would like to use these funds for the EHR which has been approved in our budget process for the grant.
