The Health Department has several grants that have included budgets specific to IT infrastructure we took the step of contacting the State PA DOH ELC grant and received an approval confirming the expense is reimbursable and is a permissible expense under the ELC grant eff through July 2024 from the project officer at the State. We expect that we will receive 2 years of the annual recurring costs back from the ELC grant. We also have IT infrastructure grant effective through 2027 that would cover any balance of the 3 year agreement and likely any renewal after the initial 3 year period.
