Grant
The Pennsylvania Commission on Crime and Delinquency (PCCD) is offering \$100,000 in competitive grant funds toward Criminal Indigent Defense Training Initiatives. Delco Defenders, in partnership with the Public Defender Association of Pennsylvania, proposes using the funds to design a systematic and comprehensive training program for public defenders that focuses on the intersection of the criminal justice and mental health systems. This will be achieved by hiring a person for a one-year training development position with the Delco Defenders. The training developer will be responsible for developing a resource manual addressing the unique nature of indigent defense of those with mental

illness, traumatic brain injury, intellectual disabilities, and developmental disabilities as well as developing a training curriculum for online and in-person trainings and coordinating two in-person trainings--one for public defenders and another for their teams (social advocates, mitigators, investigators, and support staff). The funds are sought for a term position of one year only.
